**4. General terms and conditions**

Congress participation and social programme bookings will be confirmed in writing by Intercongress GmbH. Deadline is the day of receipt of the application together with a simultaneous direct debit mandate for the amount due. All bookings are binding. All statements are required in writing. Oral agreements are only binding when these are confirmed by Intercongress GmbH in writing or via e-mail and without delay. For alterations of reservations or any other invoiced item an administrative charge of 18,00 € will be charged. A cancellation charge of 26,00 € will be charged for **cancellations until the deadline August 2, 2010**. The fee for congress participation will not be refunded, even in case of non-participation, if a cancellation is not received in time. Alternative participants are readily accepted for an administrative charge of 18,00 €. Social programmes can only be carried out if a certain minimum number of participants per programme are reached. Otherwise the programme will have to be cancelled without substitution and the paid amount will be reimbursed completely. No reimbursement will be made in case of cancellation of a social programme from a participant. Bank charges for return debit notes are on the participants account. The client agrees on a settlement of the services via fax or e-mail by Intercongress GmbH. A postal notification only occurs on explicit demand of the customer. The place of performance and jurisdiction, as far as permissible by law, is Freiburg. According to German law (§33 BDSG) all data will be stored.
